The fireworks presentation was moved up as requested by the Chair.

Fireworks presentation Ryan Dulin, Deputy Director of the Bureau of Administrative Services, San Jose Fire Department.

The department will again this year attempt to curb illegal fireworks. Several improvements to the program have been made in order to cut down on the use of illegal fireworks.

The data needs to be filled in when reporting illegal fireworks much of the information was missing. 45 on-line citations were forgiven because the review process was not standardized. 14 citations were upheld. 2800 pounds of fireworks were confiscated. There is a big black market problem many fireworks are being brought into the city illegally.

There are significant program components.

Education and Outreach Reporting and Enforcement. The message needs to get even more serious. The city is relying on citizens for reporting and will continue work on a standardized reporting process.

Some highlights of the program this year are:

## Hot line (408)535 5600 designated line for fireworks.

- 1. Redirect funds from marketing to enforcement
- 2. Evaluate technology such as sure shot spotter
- 3. Create separate hot line see above for number
- 4. Expand online reporting schedule
- 5. Coordinate messaging between departments
- 6. Overhaul campaign messaging use behavioral insights/Bloomberg
- 7. Explore reporting via mysanjoseapp. This is currently being evaluated
- 8, Cost recovery for damages this is in place in the event fires are started as a result of illegal fireworks.

## 9. The fine has been increased to \$1000.00

68 hot spots are identified through SJ and San Jose P.D. will be concentrating on those hot spots. This information is not available at this time.
